

Privacy Notice – Members and Friends

Background

RSCM is committed to ensuring your personal information is protected. This privacy notice describes how RSCM, the data controller, collects, uses and protects your information.

How we collect your information

The information we hold about you comes from the way you engage with us, such as from your membership form. We may collect information about you online through our website, via email, the post, over the phone or from discussions with you.

We may also collect details of your visits to our website including traffic data, location data, weblogs and other communications data and the resources that you access.

The type of information we hold

The information we hold may include name, address, contact telephone numbers, email addresses, DoB, the church you belong to and role within the church (if applicable), any relevant musical information associated with you and/or your church, bank details and membership history.

How we use your information

We process your information to fulfil your contract of membership and we use your information in the following ways:

- To provide you with the information about RSCM courses, events and activities.
- To ensure you receive information of local events and activities.
- To process your payments.
- To offer you the discounts you are entitled to as a Member or Friend.
- To process any donations and claim gift aid.

Who we will share your information with

We will not sell or swap your information with any agency or other charity. We will however share your information with:

- Your local area committee to allow them to invite you to their events.
- Our suppliers who manage some of our IT and web services.
- External companies that provide RSCM with member discounts (solely for the purpose of applying your membership discounts where applicable).
- HMRC to comply with legislation governing Gift Aid.

Our suppliers are bound by UK privacy law and the terms of the contracts we have with them.

Storing your information

Your personal information will be stored on systems owned or operated by RSCM or those of our specific suppliers and will only be stored inside the European Economic Area (EEA), or a country approved by the EU.

Retention

We will retain your personal information in accordance with legal and regulatory requirements. We will only retain your information while we are actively engaged with you. Where we have had no interaction with you for a period of 10 years we will delete your data.

How you can access your information

You have the right to request access to the information we hold about you. To make a request for your personal information, please contact enquiries@rscm.com.

Your Rights

You have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress;
- have inaccurate personal data rectified;
- request your information to be deleted or destroyed and if we can we will but sometimes we must maintain some records for legal reasons.

If you are not happy how we are using your information or how we have responded to your request, you have the right to complain to the Information Commissioner's Office at www.ico.org.co.uk.

Use of cookies

We may use cookies and similar technologies on our website. Cookies are small text files that may be stored on your computer or mobile device when you visit our website. Cookies do many different things, such as letting you navigate between web pages efficiently and remembering your preferences. We use cookies to track your use of our site, but we do not use cookies to make decisions about you or to send you marketing information electronically.
